NOTICE OF REVOCATION

To all concerned:

I, Brian R. Chapman, do hereby rescind or revoke my consent to the original "consent agreement" entered into the Court record as an order on 15Jan03. I present the following facts for the reasons why I am revoking/rescinding my consent:

- 1) It is an unalienable right, there is a right to contract and corresponding right not to contract.
- 2) The original "consent" agreement was used by Brenda A Chapman, to circumvent Brian R Chapman's parental rights to the minor child.--Without the "consent" agreement, Brenda Chapman would have had to prove that Brian R Chapman was an unfit parent.
- 3) The "consent" agreement was fraudulently entered into by Brenda A Chapman.
- 4) Brian R Chapman, did not have a complete understanding of what the consequences would be by entering into the "consent agreement".

5) Brenda A Chapman coerced Brian R Chapman into signing the agreement as a condition of allowing him to maintain a relationship with the minor child.

6) The "consent agreement" was "unconscionable" in that there was no evidence to show that the minor child was in any danger of being harmed in any fashion by her Father.

7) Despite being in "substantial" (*if not 100%*) compliance with the conditions spelled out in the "consent agreement" for the full restoration of parental rights/responsibilities (*joint legal/physical custody*), neither Brenda Chapman, nor the Court will allow Brian R Chapman to resume all his rights to the minor child.

I also hereby rescind/revoke my consent from all subsequent orders of the Juvenile and Domestic Relations court, and any from this Court that do not enforce my right's equally with Brenda A Chapman's.

As an action of the Common Law, by rescinding/revoking my consent/endorsement, joint legal and physical custody should automatically be restored.

The only lawful order this court can now issue is one reaffirming or declaring that joint/equal custody of the minor child is hereby restored and that the parents shall work together for the benefit of the child despite having separate households.

I swear, under penalty of perjury, that the foregoing facts are true.
